Notification

It is informed to all concerned that on the request of the students, the Vice-Chancellor has allowed to grant Special Mercy Chance on the eve of 75th Year of Independence of India for the students of all UG/PG courses who couldn't pass their course within the admissible chances/maximum duration of the course as provided in the scheme of exam till the last exam for May/June 2021, subject to fulfilment of following criterion/conditions:-

1. That student who enrolled himself/herself for their particular course in the year 2005 onwards and availed all his/her admissible chances as provided in the Scheme of Exam, stands availed/exhausted till the last exam for May/June, 2021, shall only be eligible for this special mercy chance. If anyone who has any admissible chance to pass the degree at his/her credit, as of now, shall not be eligible for this special chance. However, it is clarified that the students of following courses during the duration as indicated against each may apply for this Special Mercy Chance:-

a) One year Course(s)	2005 to 2018
b) Two year Course(s)	2005 to 2017
c) Three year Course(s)	2005 to 2016
d) Four year and Four & Half year Course(s)	2005 to 2014
e) Five year Course(s)	2005 to 2013
2. That the examinations of the papers of odd semesters will be conducted with examinations of odd semester's; and even semesters with the examinations of even semesters. The practical/Viva-Voce, if any, in any semester/year will be conducted before the odd semester's examinations. For this Special Mercy Chance the portal on the University Website for filling examination forms shall be live from **01.11.2021 to 20.11.2021**.
3. That examination for special chance shall be held in offline mode only and at the premises of University Campus/affiliated colleges. In case of any student getting positive of Covid-19 and unable to take exam through offline mode shall be provided

another chance in offline mode only on some another convenient date in future as decided by the University authorities. This shall, however, be subject to production of a valid RTPCR report issued by the Govt./Civil Hospitals only and no extra fee shall be charged from such students. The test report must be submitted by the student concerned well before the date of concerned examination otherwise the same shall not be considered. No online examination will be held in any circumstances for this special chance.

4. That for this special chance, Fee of Rs. 12000/- per semester in case of semester exam and the same fee per year in case of annual exam will be charged from the students of all courses run in the University Teaching Departments including MBA evening as well as in Affiliated Degree/Engineering/ Education/Management Colleges and under Directorate of Distance Education. **Fee once paid shall not be refunded/adjusted.**
5. That students are also advised that before submission of online examinations from and fee, they must check/ensure their eligibility, and in case of any doubt, they must confirm it from the Result Branch concerned. If any "INELIGIBLE STUDENT/CANDIDATE" submits his/her examination form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case. All the students desirous of availing this chance are advised to read the following conditions/instructions carefully:-
 - i) The examination for the special chance shall be conducted as per the scheme/syllabi, as applicable for each course. If the scheme and syllabi of any paper is not available in the University the same will be got prescribed by the Academic Branch from the Dean/Chairperson of the faculty/department concerned.
 - ii) The examination forms and fee shall be filled up through online mode **from 01.11.2021 to 20.11.2021.**
 - iii) The schedule of examination/declaration of result will be notified depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of result.
 - iv) This special chance is admissible to complete the Degree (course) for such students who have re-appear in one or more papers (subjects) and also for improvement of division, who could not improve division within their admissible chances. **However, Improvement is not permissible for Education courses.**
 - v) If any student before the session of 2005 wants to apply for Special Mercy Chance

the same may be considered on his/her written request with an additional fee of Rs. 1500/- per semester/year, as the case may be. Thus, such students may deposit Rs. 13500/- as fee for this Special Mercy Chance under reference.


- vi) If result of any student is not declared upto 20.11.2021 and he/she is otherwise eligible for applying this special mercy chance as per above criteria, he/she can apply within 07 days from the declaration of his/her result. **However, no such request will be entertained after 15.12.2021 under any circumstances.**
